The Radnor Educational Foundation (REF) is a 501(c)3 nonprofit organization whose mission is to secure and provide funding and support to enrich the educational experience, maintain academic excellence, and encourage innovative opportunities for the students in the Radnor Township School District.

Through three grant cycles, REF distributes funds to support programs and projects in the following categories: STEAM (Science, Technology, Engineering, Arts and Math) Programs, Curriculum Enhancement, Cultural Arts, Technology, Professional Development, and Community Engagement.



Since its inception, the Radnor Educational Foundation has awarded almost \$1.5 Million in grants to the Radnor Township School District!

In an average year, REF supports between 15 - 20 innovative projects and programs that enhance the educational and social experience for our students in all five Radnor schools.

Grants typically range from a couple hundred dollars for smaller requests to larger school- and district-level grants in the range of tens of thousands of dollars.

In addition to the grants we provide, through our **Neighbors Helping Neighbors** program, REF partners with district social workers to assist families facing temporary financial hardship, as these circumstances often affect a student's ability to participate fully in school life. Over the past decade, Neighbors Helping Neighbors has supported numerous district families by assisting with basic life needs such as housing, utilities, food and clothing.

GET A TAX BREAK THROUGH EITC!



The Pennsylvania Educational Improvement Tax Credit (EITC) program provides companies with a 75% tax credit for donations to a non-profit scholarship or educational improvement organization. The tax credit increases to 90% if the company commits to making the same donations for two consecutive years. A business that pays taxes in Pennsylvania can receive up to \$750,000 in tax credits annually. The full amount of the contribution for all these organizations is deductible for federal tax purposes as a charitable contribution. Credits are awarded to companies on a first-come, first-serve basis until the cap is reached, so businesses should apply when the next application period opens!

Businesses that wish to be approved to use tax credits must submit applications beginning **July 1**. Businesses that are renewing their approval can do so beginning on or around **May 15** of each year.

Once approved as an EITC donor, businesses can select programs based on their target market, business relationships, geographical interest, or other factors.

HOW TO APPLY

1. Businesses submit an online application to the Pennsylvania Department of Community and Economic Development (DCED) indicating what amount they plan to contribute.
2. The DCED will notify businesses that have been approved.
3. After receiving the approval, businesses have 60 days to make the contribution to an approved organization.
4. Businesses must provide the DCED with a copy of the confirmation of contribution from the EITC organization (a letter of receipt).
5. The DCED will communicate with the PA Department of Revenue, and the applicable tax credit will be applied to the business' tax account.
